Starport is open mid-April and closes mid-October each year. This rv campsite license is valid only to the rv owner and rv listed above when completed, and covers the period of rental described above. This space and other marina/campground facilities are to be used at the sole risk of the boat owner and their registered guests. Starport Marina and/or the owner of the real property are not responsible for any theft or damage of any kind to boats, rv's, their contents, gear, and equipment. No warranty is expressed or implied, as to the condition of the docks, walkways, depth of water, the grounds or other related site features and facilities. Starport Marina and/or the owner of the real property is not responsible for injuries to persons or property occurring thereon. The boat/rv owner shall indemnify and hold Starport Marina and the owner of the real property harmless for any and all injuries and/or damages of any kind.
